

Bryan University is required to provide current and prospective students, and employees with an annual report that identifies policies and procedures related to campus security to comply with the Jeanne Clery Disclosure of Campus Security and Crime Statistics Act in efforts to increase awareness of current policies, procedures and practices related to campus security.

This report is prepared from information provided by the Public Safety and the statistics and information are gathered from crimes reported on campus as well as from the Tempe and Los Angeles police departments.

A truly safe campus can only be achieved through the cooperation of students, faculty and staff. As a member of the Bryan University community, it is your responsibility to report a crime, suspicious activity or other emergencies on campus to the appropriate school official. Should you become witness to or victim of a crime, immediately report the incident to local law enforcement officials and the Student and Alumni Outreach office or if faculty or staff, report immediately to human resources.

### **Timely Warning and Emergency Notification**

When making your report of an incident you will be asked to provide the following information:

- 1. Description of the incident
- 2. Date, time and location of the incident
- 3. Description of the persons or vehicles in the incident
- 4. Detail regarding who was notified about the incident

Upon receipt of the report (can be physically submitted or emailed to security@bryanuniversity.edu), Bryan University will determine the appropriate response, which could include disciplinary action against the offender(s), notification to local law enforcement, notification to the campus community or other public safety alternatives. Please note that your identity may not be confidential when reporting an incident to authorities.

Remember for all emergencies dial 911. Bryan University will gather police reported crime applicable to our locations in Tempe and Los Angeles, which are disclosed at the end of the report.

Should any emergencies occur on campus, the fire bells will ring to signal the need to vacate the premises. In addition, alerts will be posted to the Bryan twitter account. Emergency exit plans are posted within wall placards in each classroom throughout the campus.

Please make sure to keep your contact information updated within Student Portal to ensure timely receipt of all emergency communications.

### Campus Access, Facility Security and Law Enforcement



Bryan University Los Angeles Campus: Bryan University Los Angeles is located at 3580 Wilshire Blvd. Suite 400, Los Angeles, CA 90010, near the corner of Wilshire and Ardmore. Access to the University is excellent by freeway or public transportation. Students and employees have access to a secure, gated, covered parking structure adjacent to the building. Building security officers are available 24/ and monitor building and parking security. The main security office is located right outside the lobby. Hours of operation are Monday through Friday, 8:00am to 4:00pm.

Key cards are required for access outside of normal operating hours. There are fire alarm pull stations throughout the campus and should only be used in the case of an emergency. There are signs clearly posted throughout the building indicating the best routes for evacuation.

Bryan University Tempe Campus: Bryan University Tempe is located at 350 West Washington Street, Suite 100, Tempe, Arizona 85281, at the corner of Mill Avenue and Washington Street. The campus is easily accessible via light rail and the 101 and 202 freeways, being located only 1.5 miles from Phoenix Sky harbor International Airport. Bryan University Tempe is open between 8:00am and 10:00pm Monday through Thursday and Friday, 8:00am to 5:00pm. Building management has provided live security officers from 8:00am to 5:00pm Monday through Friday. Once the live officers have left, one must have a security access key card to enter any part of the facility. University employees and students must report a loss of their security card so that it can guickly be deactivated and replaced.

Bryan University Tempe also has a secure parking garage adjacent to the facility for employees and students.

### **Safety and Security Tips**

#### Personal:

- 1. Stay alert and tuned into your surroundings
- 2. Communicate that you are calm, confident and know where you are going
- 3. Stay on sidewalks
- 4. Walk with a companion whenever possible
- 5. Check the back seat of your car before getting in
- 6. Avoid displaying large amounts of cash or jewelry
- 7. Don't pick up hitchhikers
- 8. Park in lighted areas



9. Never admit your are away from home

#### Residence:

- 1. Keep doors locked at all times
- 2. Draw shades and curtains whether or not you are home
- 3. Leave a light on while you are away
- 4. Never prop doors open
- 5. Keep ladders and tools in a locked area
- 6. Have someone cut your lawn while you are on vacation

#### Vehicle:

- 1. Always lock your car and remove the keys. Make sure windows are closed
- 2. Lock all valuables in the trunk
- 3. Never leave an ID tag on the keys
- 4. Park in lighted areas

#### Office:

- Keep your purse, wallet and other valuable items with you at all times or locked in a drawer or closet
- 2. Never leave keys lying out
- 3. Never leave cash or change on the desk or in top drawer
- 4. Lock doors when working after hours
- 5. Report any broken or flickering lights, and doors that don't lock properly

#### **Sexual Offence Awareness**

#### Definitions:

<u>Dating violence</u> is defined as violence committed by a person who: is or has been in a social relationship of a romantic or intimate nature with the victim; and where the existence of such a relationship shall be determined based on a consideration of the following factors: (1) the length of the relationship; (2) the type of relationship; (3) the frequency of interaction between the persons involved in the relationship.

<u>Domestic violence</u> is defined as felony or misdemeanor crimes of violence committed by a current or former spouse or intimate partner of the victim, by a person with whom the victim shares a child in common, by a person who is cohabitating with or has cohabitated with the victim as a spouse or intimate partner, by a person similarly situate to a spouse of the victim under the domestic or family violence laws of the jurisdiction receiving grant monies, or by any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction.



<u>Forcible sexual offenses</u> are defined as, "Any act directed against another person, forcible and/or against the person's will; or not forcibly or against the person's will where the victim is incapable of giving consent," and include, forcible rape, forcible sodomy, sexual assault with an object, and forcible fondling.

<u>Non-forcible sex offenses</u> are defined as "Unlawful, non-forcible sexual intercourse," and include incest and statutory rape.

<u>Rape</u> is defined as sexual intercourse that is coerced through force or threats of forcibly, or with someone who is unconscious, or incapable of giving consent.

<u>Sexual assault</u> is defined as an offense classified as a forcible or non-forcible sexual offence that is physical contact of a sexual nature, which is against one's with or without one's consent.

<u>Stalking</u> is defined as engaging in a course of conduct directed at a specific person that would cause a reasonable person to: (1) fear for his/her safety or the safety of others; or (2) suffer substantial emotional distress.

**Procedures to follow after an Assault:** Victims of sexual assault or rape are strongly encouraged to report the incident in order to deter these assaults and to ensure that victims receive the services they need. Steps should be taken to help deal with the physical and emotional trauma:

- 1. Go to a safe place; go somewhere to receive emotional support.
- 2. Report a sexual assault on campus to the Dean of Student Affairs or local leadership.
- 3. Report the assault to the police. If requested, Bryan University will assist with notification.
- 4. Preserve all physical evidence. Do not shower, bathe or douche and save the clothing worn.
- 5. Go to the hospital for medical care. Injuries should be treated and an examination completed to document and collect physical evidence of the assault. Bryan University will assist with transportation if necessary.
- **6.** Seek professional counseling. This can help in the recovery from the psychological effects of the assault.

Please refer to the Resources for Victims of Sexual Assault section of this document for a list of local resources that will provide immediate advice and assistance to victims of sexual assault or rape. Victims of a sexual assault or rape may request a change in their academic arrangements by contacting their Program Director. Changes will be made if feasible and reasonable to do so. All reports filed with Bryan University will remain confidential. Staff and faculty should report any on-campus sexual offenses to the Provost and the proper authorities.

<u>Disciplinary Action:</u> Disciplinary procedures and sanctions as outlined in the Student Code of Conduct will be followed once charges are brought after an alleged sexual assault. Both the accuser and the accused are entitled to the same opportunities to have others present during a disciplinary hearing. Both the accuser, upon his/her written request, and the accused, of a crime of violence or a non-forcible



sex offense, will be informed of the results of any disciplinary proceedings conducted as a result of an alleged sexual assault.

#### **Campus Sex Crimes Prevention Act**

The Campus Sex Crimes Prevention Act requires sex offenders already required to register in a State to provide notice, as required under State law, to each institution of higher education in that state at which the person is employed, carries on a vocation, or is a student. The act requires that state procedures ensure this registration information is promptly made available to law enforcement agencies with jurisdiction where the institutions of higher education are located and that it is entered into appropriate state records or data systems. These changes became effective two years after enactment of the law (2002). This act amends the Higher Education Act of 1965 to require institutions of higher education to issue a statement, in addition to other disclosures required under that Act, advising the campus

community where law enforcement agency information provided by a State concerning registered sex offenders may be obtained. This change takes effect two years after enactment (2002).

This act amends the Family Educational Rights and Privacy Act of 1974 to clarify that nothing in that Act may be construed to prohibit an educational institution from disclosing information provided to the institution concerning registered sex offenders; requires the Secretary of Education to take appropriate steps to notify educational institutions that disclosure of this information is permitted.

#### **Drug and Alcohol Policies**

Bryan University is committed to having a drug-free and alcohol-free campus that prohibits at a minimum, the unlawful possession, use, or distribution of illicit drugs and alcohol by students and employees.

#### **Standards of Conduct**

Use of illegal drugs, and the illegal use of alcoholic beverages, is identified as "conduct that adversely affects the community." University regulations prohibit any unlawful possession, use, distribution, or sale of alcohol and other drugs by University students, faculty, staff, or guests of the University, on University property and at all University sponsored events.

Bryan University students and employees are also prohibited from the illegal use of drugs or alcohol whether on or off campus.

The legal age for the consumption of alcohol is 21 years of age. Any underage student consuming alcohol is violating standards for student conduct. Additionally, excessive use of alcohol can lead to additional violations, such as driving while intoxicated or public intoxication.

#### **Disciplinary Sanctions**



The penalties for misconduct range from admonition to expulsion. Typically, students who have violated this policy or the Student Code of Conduct (outlined in the Catalog) will be referred to Student and Alumni Outreach for assessment. Examples of sanctions include:

- 1. Written warning
- 2. Probation
- 3. Fines
- 4. Restitution
- 5. Suspension
- 6. Expulsion

Employees or staff that are not in compliance with this policy (or the drug polices outlined in the employee manual) will be referred to human resources and may be suspended, loose wages, or terminated.

In addition, known student or employee violations, if required by state law, will be brought to the attention of local law, state, and or federal enforcement agencies.

Disciplinary sanctions may also include completion of an appropriate rehabilitation program.

In addition to University imposed sanctions, local law, state, and federal enforcement sanctions may also be imposed, including, but not limited to the following:

- Tempe Arizona Campus In addition to the Federal Laws, the State of Arizona has its own laws dealing with controlled substances. It is illegal for persons under the age of 21 to possess alcoholic beverages with the intent to consume them, and for anyone to falsify or misrepresent his or her age to another person under that age of 21. Arizona law (ARS & 8-323) provides for the following penalties for a minor who purchases, possesses or consumes spirituous liquor:
  - 1. Probation
  - 2. A juvenile court hearing
  - 3. Driving privileges suspended for 180 days
  - 4. Attendance at a counseling for education program
  - 5. A find up to \$500
  - 6. Community service work

Arizona law also makes it a misdemeanor to be intoxicated in public and cause a public disturbance, or to be intoxicated and endanger the safety of another person or of property. This carries a fine of up to \$1000 and up to 90 days imprisonment. Penalties for drug possession under Arizona law range from a minimum of probation to a maximum of 10 years in prison and a \$150,000 fine.

Information is given for first offenses only as repeat offenses carry progressively greater sanctions. Trafficking (selling) any illegal drugs, excluding alcohol, are all felonies.

- Los Angeles Campus Underage consumption and or possession of alcohol is considered a
  misdemeanor, with driving privileges suspended for one year and \$125 fee. If found with an
  open container of alcohol in motor vehicle, it's a misdemeanor and \$390 fine. Driving under the
  influence is a misdemeanor with 48 hours to 6 months jail time and up to \$1000 in fines. If
  found in possession of narcotics, instant felony with two years to 10 years jail time plus fines.
  Addition offenses penalties increase.
- Federal Federal law penalizes the unlawful manufacturing, distribution, use, sale, and possession of controlled substances. The penalties vary based on many factors, including the type and amount of the drug involved, and whether there is intent to distribute. Federal law sets penalties for first offenses ranging from less than one year to life imprisonment and/or fines into \$10 million. Penalties may include forfeiture of property, including vehicles used to possess, transport, or conceal a controlled substance; the denial of professional licenses or Federal benefits, such as student loans, grants, and controls; successful completion of drug treatment program, community service; and ineligibility to receive or purchase a firearm. See Federal Controlled Substances Act at 21 USC 800.

#### **Health Risks**

Specific serious health risks are associated with the use of alcohol and illicit drugs. Some of the major risks are listed below.

#### General Risks:

- · Physical and mental dependence
- Memory Loss
- Violent behavior, aggressive acts, and angry feelings
- Headaches
- Nausea or vomiting
- Muscle weakness
- A drug tolerance
- Liver, lung, and kidney problems
- Brain damage
- Hallucinations, tremors and convulsions
- Hyperactivity or Sluggish behavior
- Poor academic performance
- Unwanted sexual activity (i.e. date rape)
- Sexually transmitted diseases, including HIV/AIDS
- Unwanted pregnancy
- Impact on future career prospects
- Adverse effects from withdrawal



### Specific Risks:

Alcohol and Other Depressants (barbiturates, sedatives, tranquilizers) – Addiction, accidents as a result of impaired ability and judgment, alcohol poisoning, overdose when used with other depressants, damage to a developing fetus, heart and liver damage.

*Marijuana* – Impair short-term memory, thinking, and physical coordination. Can cause panic reaction and increase risk of lung cancer and emphysema. Can interfere with judgment, attention span, concentration, and overall intellectual performance. Impairs driving ability. May cause psychological dependence and compromised the immune system.

**Cocaine** – Addition, cardiovascular system damage including heart attack, brain damage, seizures, lung damage, severe depression, paranoia, psychosis. Similar risks are associated with other stimulants, such as speed and uppers.

**Nicotine** – Tobacco smoke contains thousands of chemical compounds, many of which are known to cause cancer. Nicotine, which is a central nervous system stimulant, produces an increase in heart and respiration rates, bold pressure, adrenaline production and metabolism. People can rapidly become physically and psychologically dependent on tobacco. Compromises the immune system.

*Inhalants* – Inhalants are a diverse group of chemicals that easily evaporate and can cause intoxication when their vapors are inhaled. Most inhalants are central nervous system depressants. Use of these drugs slows down many body functions. High doses can cause severe breathing failure and sudden death. Chronic abuse of some of these chemicals can lead to irreversible liver damage and other health problems.

*Prescription Drug Abuse* – Adverse reactions, dependency, withdrawal, and overdose.

### **Counseling and Treatment**

A variety of resources exist for alcohol and other drug prevention education, counseling and referral. Employees may contact the Bryan University Human Resources Department at 888-768-6861, Monday through Friday from 8am PST to 5pm PST. Students may contact Student and Alumni Outreach also at 888-768-6861, Monday through Thursday from 6am PST to 8pm PST.

For those individuals that require assistance outside of the aforementioned operating hours, or for online students and employee that need assistance from local state services, Bryan University has partnered with Wellconnect, which is available 24/7 at 866-640-4777.
